Call for Application

Applications are invited from the eligible candidates for admission to M. Sc. & M.B.A. programmes. The candidates may download the application form and guidelines from the institute website (www.nits.ac.in). The processing fee is Rs. 500/- (Rupees Five Hundred Only) non-refundable for Gen/EWS/OBC & Rs. 250/- (Rupees two hundred Fifty) for SC/ST/PwD. The payment should be made only through State Bank Collect (SB Collect at State Bank of India (http://www.onlinesbi.com), SBI Collect>Accept>Assam>Educational Institute>Online Fee Collection Account NIT Silchar>Select Category (M.Sc. / M.B.A. Fee). The filled-in application form along with required enclosures and the printout of the registration fee payment proof should reach "The Office of the Dean(Academic), National Institute of Technology Silchar - 788 010, Assam" before 5:00 pm on or before 31st July, 2020 in a sealed cover superscribing "Application for M. Sc. / M.B.A." Programmes under Sponsored Category/Project Staff/Institute Employee for 2020-2021. Eligibility Criteria for M.Sc. Programmes

Bachelors' Degree (at least 10+2+3) in Science with the appropriate subject as one of the subjects for at least two years/four semesters (e.g. Physics for M.Sc. in Physics), and a minimum score of 55% or 6.0 CPI/CGPA in a 10 point scale either as aggregate or in honours/major subject. A relaxation of 5% marks or 0.5 CPI/CGPA may be extended to the candidates belonging to SC/ST/PWD categories. However, the concerned Departments may specify additional requirements over and above these minimum requirement. Candidates having valid JAM score (if any), will be given preference.

Eligibility Criteria for M.B.A. Programme

- minimum requirements.
- (a) Sponsored (Full-time)

A candidate, in this category, is sponsored by a govt/semi-govt/public sector organization for admission on a full-time basis. He/she must be a regular employee of the concerned organization and have at least one year of working experience in the respective field/area at the time of application. Sponsorship letter (Form I) needs to be attached along with the application for consideration.

(b) Sponsored (Part-time)

This category refers to the candidates who are working on sponsored projects in the Institute and desires to join the Program as a part-time student. The left-over duration of the project at the time of admission needs to be at least one year. A no objection certificate (Form III-A) is to be attached with the application.

Short-listing / Selection Criteria

The admission to M. Sc. / M.B.A. Programmes will be based on performance during selection process by the respective Departments. Mere call for interview does not guarantee admission. The Institute reserves the right to reject any or all applications or it may amend any of the clauses above as per orders of the competent authority/ Government of India. Selection procedure will be held during 10th – 11th August, 2020. No interim correspondence will be entertained.

Programme Features

Sponsored candidates may be permitted to carry out the Project Work at their parent organization. There may be a guide from the sponsoring organization for each sponsored student apart from the internal guide from NIT Silchar. Sponsored candidates are encouraged to publish papers in web of science / Scopus indexed journals. A joint patent in the name of institute and industry can also be filed. For a full time student, the minimum & maximum durations for completion of the programme is 4 & 6 semesters respectively. For a part-time student, these durations are 6 & 8 semesters respectively.

• Bachelor degree (at least 10+2+3) of regular course, with at least 55% marks or 6.0 CPI/CGPA on 10 point scale in aggregate. A relaxation of 5% marks or 0.5 in CPI/CGPA may be extended to the candidates belonging to SC/ST/PWD categories. However, the Department may specify additional requirements over and above these

Candidates having valid CAT/MAT/CMAT score (if any), with at least fifty (50) percentile qualifying score will be given preference.

This category refers to the candidates who are professionally employed and can attend classes at the Institute while employed. These students need to attend regular classes as per the class schedule. The applicant must be a regular employee of a govt/semi-govt/public sector organizations with at least one year of experience at the time of application, and be engaged in professional works related to the discipline in which admission is sought. A no objection certificate (Form II) needs to be enclosed along with the application.

A regular employee of the Institute may be sponsored as a part-time students by the Director, on recommendation of Head of the Department/section in which the employee is working. The employee must have completed at least two years of continuous service in the Institute at the time of admission. A no objection certificate (Form III-B) is to be attached
