Important Points:

1. The candidates who are provisionally selected for admission to the MBA Programme 2023-25 of the Department of Management Studies, NIT Silchar have to submit the Registration Fee for the First Semester (without hostel accommodation) of amount Rs 87,370/- (Rupees Eighty Seven Thousand Three Hundred and Seventy Only) and with hostel accommodation Rs. 90,500/- (Ninety Thousand Five Hundred Only) through online on or before 25th June 2023 (Sunday). The detailed fee structure is available at the Institute Website (www.nits.ac.in).

2. The candidates are advised to submit the requisite amount of Registration Fees through SB Collect portal. This portal will be active to receive the Registration Fee for the selected candidates for MBA Programme 2023-25 from 15th June, 2023 (Thursday) onwards.

Steps for Online Payment

- I. Open the Website: (www.onlinesbi.com)
- II. Select "State Bank Collect" tab at the top.
- III. Click check box at the bottom, accept and proceed.
- IV. Under State Bank Collect
 - V. State of Institute > Assam
- VI. Type of Institute > Education Institute > Go.
- VII. Educational Institute Name > Select "Online fee collection account NIT Silchar" for admission fees payment > Select payment category (MBA Admission 2023-25) and fill the required fields and submit.
- 3. If any candidate fails to pay the Registration Fee mentioned above within the stipulated date (25th June 2023), their candidature shall be treated as cancelled and seats will be forfeited. The forfeited seats will be allocated to waitlist Candidates.
- 4. After making the online payment, the candidates are advised to save the receipt copy in pdf format and email the same as a proof of payment to doms.admission@mba.nits.ac.in (on or before 25th June 2023) along with the following information:

The candidates selected for admission to the MBA Programme 2023-25 are required to provide the original certificates and Mark-sheets of all the examinations from Class 10th onwards leading to the qualifying degree, Category certificates, CAT/MAT/CMAT score cards, proof of age etc.at the time of course registration at the Institute or during document verification as the case may be.
