Important Points:

- 1. The candidates who are provisionally selected for admission to the MBA Programme 2022-24 of the Department of Management Studies, NIT Silchar have to pay the Registration Fee for the First Semester (without hostel accommodation) of amount Rs 87,370/- (Rupees Eighty Seven Thousand Three Hundred and Seventy Only) and Rs. 90,500/ (With Hostel) through SBI Collect on or before 15th July, 2022. The detailed fee structure is available at the Institute Website (www.nits.ac.in).
- 2. This portal will be active to receive the Registration Fee for the selected candidates from 11th July, 2022 to 15th July, 2022.

Steps for Online Payment

- I. Open the Website: (<u>www.onlinesbi.com</u>)
- II. Select "State Bank Collect" tab at the top.
- III. Click check box at the bottom, accept and proceed.
- IV. Under State Bank Collect
 - V. State of Institute > Assam
- VI. Type of Institute > Education Institute > Go.
- VII. Educational Institute Name > Select "Online fee collection account NIT Silchar" for admission fees payment > Select payment category (Second Phase MBA Admission 2022-23) and fill the required fields and submit.
- 3. If any candidate fails to pay the Registration Fee mentioned above within the stipulated date (15th July 2022), their candidature shall be treated as cancelled and seats will be forfeited.
- 4. Fee once paid will not be refunded.
- 5. After making the online payment, the candidates are advised to save the receipt copy in pdf format and email the same as a proof of payment to doms.admission@mba.nits.ac.in (on or before 15th July 2022) along with the following information:
